| <p>1. <u>Apologies for absence and announcements</u></p> <p>David Buckley and Ewan Larcombe were both involved with their election preparations.</p> | | | | | | | | | | | | | |
| <p>2. <u>Preparations for the Referendum</u></p> <p>AC confirmed that copies of the Plan were in the Library and The Bridge (the first one having been taken!) and that leaflets / posters had been accepted by a number of businesses in the village, i.e. two estate agents, Candy Box, Enzos.</p> <p>The A4 leaflets had been reprinted with the Imprint information and AC handed these out. MC had divided up the village and areas were allocated to all present. It was hoped that these leaflets would be delivered asap.</p> <p>FC advised that Locality had said they didn't have the expertise to advise on whether the fund obtained had to be returned to RBWM – they suggested we ask RBWM.</p> <p>DPC's Clerk thought the Plan information could be archived at the Berkshire Archives.</p> <p>AC had arranged two drop-in sessions at The Bridge for villagers to come and chat about the Plan.
